The Government have decided to take up the Prajapatham - 2010  
programme from 19<sup>th</sup> April to 14<sup>th</sup> May, 2010 and 15<sup>th</sup> May 2010 is Punarankitha sabha  
(rededication day) at District Level. The priority themes to be focused during the  
programme have been finalized as follows:

1. Drinking Water
2. Employment Generation (MNREGA)
3. Assured Power supply for 7 hours per day.
4. Rajiv Aroghyasri.
5. Awareness on availability of '108 and 104' services
6. Health - Information, Education & Communication (IEC) campaign.
7. Street lights and Domestic water supply in urban areas.

Through the reference cited, the Special Chief Secretary to  
Government, Planning department, Hydrabad have communicated guidelines for  
smooth and successful conduct of Gramasabhas covering 100% Grampachayats /  
Mpl.Wards. A copy of guidelines received from Government are anclosed.

Keeping in view the guidelines , all preparatory arrangements may be  
made for conducting the Programme in the mandal/ municipality . It is also requested  
to :

- Finalise the visit schedule in consultation with MLA and shall be furnished to  
the Chief Planning Officer for placing in the WEB SITE immediately.
- The Daily Status Report has to be furnished to the Chief Planning Officer on the

- Conduct a meeting of all mandal level officers and may be requested to cover  
all GPs in advance to ascertain issues likely to come up in the programme .
