

Minutes of the Convergence Meeting held by District Collector, Anantapur on 30.8.2010 at DWMA Conference Hall, Anantapur

The District Collector reviewed the status of Prajaavani Petitions category & department wise and instructed to redress all "A" category petitions at the earliest. It is also informed that any slackness in redressing the petitions will be viewed seriously.

Other instructions issued by the District Collector during the meeting are:

1. To display the movement of executive staff, i.e. VRO/RI/DT/Surveyor/Tahasildars in Tahasildar Offices for the Public convenience.
2. All the District Officers to personally attend Prajavaani grievance cell on every Monday at 10.00 AM without sending the next cadre officers to know the gravity of the problems. All public petitions to be redressed at Village or Mandal level it self without encouraging them to approach District level for smooth redressal system.
3. To put the SC Corporation beneficiaries feasibility certificates issuing programme in fast track and also to give weekly progress on each Department wise issues in the Convergence meeting. **Action : SE TRANSCO**
4. To give complete all the 36000 houses belonging to SC and STs by next week. To give sanction orders with in next week to the collapsed houses for the recent rains victims, for whom relief paid by the RDOs immediately with in 24 hours. It is also instructed to prepare power point presentation for the meeting scheduled on 7.9.10 to the Special Officers. **Action :: PD Housing.**
5. To improve the attendance percentage in schools and Colleges. **Action :: DEO & RIO**
6. To cross check the closing balances under mid day meal scheme with absentee students % and Hostel boarders of the schools.
7. To appoint the Divl. Co-operative Officer as special officer, Anantapur and the JD AH as special Officer, Guntakal.
8. To pay relief by the concerned officers to the accidental cases in any schemes with in 24 hours of the occurrence.
9. To continue the previous tutors / Vidya volunteers now also unless any defective discharge of duties noticed.
10. To give one line SMS on sanction of Scholarships every week to the District Collector. **Action : DD SW, DBCWO, DTWO and DMWO**
11. To upkeep the ambiance in all Welfare Hostels with local funds mobilization, one dictionary in all rooms, and also drinking water purifiers .
12. To run RTC buses in rural interior areas to accommodate the school timing to the students.

13. To go for EOI with contractor to construct and maintain sulabh complexes at Puttaparthi.

Action :: DPO

14. To visit all hostels by Special Officers to improve the ambiance of the Hostels .

ISSUES DISCUSSED IN THE MEETING

- The P.O Rajiv Vidya Mission informed that the Govt is launching a new programme to the street children and out of school children of school going age to cover in school education. For this purpose two reception centres at the Railway stations of Anantapur and Guntakal are proposed to motivate the street children and one transit home located in Brahmanapalli (V) of Kudair Mandal is proposed for the short stay of the children. This programme is being tied up with the NGOs participation. Hence requested all special Officers to take the message to the villages. In this connection the District Collector advised the RDT to deliver the service with funding by the RVM and a MOU to this effect to be executed.

Action :: PORVM & RDT

- The SE RWS informed that the compensatory a forestation land identification is completed by the RDO, Penukonda and the Proposals to be further processed by the DFO (T) to complete the J C Nagireddy Drinking water project. **Action:: DFO (T).**
- The SE RWS informed that under JALAMANI programme ; intended to supply germ free drinking water to schools children; 100 purifiers are available with the agencies and shortly going to be installed in schools.
- The SE TRANSCO informed that special Meters providing programme @ Rs 125/-to BPL families is in force up to 31.12.2010, and the service wire is also part of the unit cost and need not be paid more than that.
- The PO RVM informed that in Madaksira, Kalyanadurg, Kundupri, Brahmasamudram, Kambadur, Yellanur mandals the power connections are not being provided to the deposit paid schools for the reason that there are no sufficient Meters. Hence requested to rectify the problem. **Action:: SE TRANSCO.**
- The SE Minor Irrigation raised an issue of shifting of Electric poles abstracting for the newly erected Father Ferrer statue at Collectorate. Hence requested to furnish the estimates for shifting the poles. **Action :: SE TRANSCO**
- The ED S.C Corporation/ DTWO requested not to disconnect power supply to the Tribal Welfare Girls hostel located in Housing Board Colony which is being run in a Private building for non payment of bills, as all dues will be cleared immediately after receipt of budget from Government. **Action :: SE TRANSCO**
- The DBCWO requested to provide buses to BC Girls Hostel for facilitation of the College going girls. **Action:: RM APSRTC.**

- The RDO Penukonda raised the previous issue of providing land to construct Social welfare Girls hostel at Penukonda. As the site is identified at ZPH School compound requested the EE Social welfare to approach the CEO ZP for necessary action. **Action :: EE SW & CEO ZP**
- The RDO, Anantapur informed that in Vidapanakal School there is no allotment for the new admissions strength of 100 students and requested to rectify the defect. **Action :: DEO**
- The Deputy Commissioner of Labour requested to provide the list of builders to collect construction workers welfare cess. **Action :: ATP Mpl. Commissioner**
- The Joint Collector requested to inspect for financing the newly formed women SHGs of Handloom weavers in Uravakonda town. **Action :: AD H & T and PD DRDA**
- The EE SW requested to pay the repair charges for the works done at Thimmammamarrimanu. **Action :: DPRO**
- The PD Housing raised the previous issue of furnishing the utilization certificates by the SE TRANSCO and RWS in the revised format communicated to all concerned immediately. **Action SE s of TRANSCO & RWS**
- The EE SW requested to develop kitchen gardens in all hostel with linkup with AD Horticulture- I. For which sufficient water to be supplied by the Public Health or RWS. **Action:: AD Horticulture and local bodies.**
- The District Manger NEDCAP requested all officers to change the 5 year old tube lights in their offices with T 5 tube light to save energy. **Action: All Officers.**
- The DRO instructed to collect Mandal wise target fixed to collect water rate with in no time for adjustment to Irrigation department. **Action :: RDOs**
- The District Revenue Officer requested to furnish the list of victims of heavy rains received during April 2010 relating to Agrl Department to the Collectorate. **Action:: JD Agrl.**

Before concluding the meeting, Dist. Collector instructed the RM RTC to run more number of buses, Dy. Labour Commissioner to close all Xerox centres, DM & HO to depute personnel for first aid at examination centres, and the Tahasildar, Anantapur to impose 144 section at the centres for smooth conduct of Group I examinations scheduled on 5.9.10.
