- ❖ **BANK LINKED SCHEME:** Under Bank Linked programme 901 units for the benefit of 1069 SC beneficiaries with an outlay of Rs.657.58 lakhs. The S.C. Society has sanctioned 813 units for the benefit of 817 SC beneficiaries the expenditure incurred for Rs.496.256 lakhs.
- ❖ **DAIRY:** Targets allotted 181 units for the benefit of 181 SC beneficiaries with an outlay of Rs.145.99 lakhs. The S.C. Corporation has sanctioned 335 units for the benefit of 335 SC beneficiaries the expenditure incurred for Rs.230.970 lakhs.
- ❖ **TRAINING PROGRAMME:** For SC unemployed youth with an outlay of Rs.25.80 lakhs. The S.C. Corporation has taken up training programme under LMV Driving at APSRTC, Anantapur and 50 candidates are undergoing training.
