

Minutes of the Convergence Meeting held on 17-01-2011 at DWMA Meeting Hall

The Joint Collector, Anantapur initiated the proceedings with review of preparatory arrangements for the ensuing Rachabanda Programme scheduled from 24th January to 12th February 2010 in the district. As part of this, the Joint Collector, Anantapur initially took up review of the redressal status of grievances raised in Prajapatham held from 19th April to 14th May 2010 and requested all the District Officers concerned to immediately attend the redressal of the pending issues since as per the directions of the Government, the grievances are to be completely redressed before the commencement of Rachabanda programme and also furnish the latest status reports to the Chief Planning Officer, Anantapur by 20th January 2011. (Action : All the District Officers)

Preparatory Arrangements for Rachabanda Programme :

The following instructions are given to the District Officers and Special Officers for successful and smooth implementation of the programme :

- To ensure finalization of tour schedule in consultation with local MLA. Revenue Divisional Officers to intervene wherever necessary in finalizing the tour schedule of Rachabanda programme.
- To ensure communication of tour schedule well in advance to all the Hon'ble Public Representatives and to ensure participation of mandal level functionaries of all departments
- To have awareness on the thrust areas of Rachabanda particularly with regard to Ration Cards and Housing .
- To conduct the rachabanda programme as per the guidelines communicated by the Government.
- All the officers including Municipal Commissioners to attend the meeting on Rachabanda Programme. In Revenue Bhavan at 2.00 PM on 21st being taken up Hon'ble District Incharge Minister .
- All District Officers to ensure participation of mandal level functionaries in Rachabanda Gramasabhas (Action : All Special Officers)

The District Revenue Officer, Anantapur requested the District Officers to immediately send the nominations for consideration of awarding meritorious certificates on Republic Day Celebrations duly indicating the remarks for nominating the employees. (Action: All the District Officers)

In view of National Voters Day being observed on 25th January , the Joint Collector, Anantapur directed the District Educational Officer and Coordinator, Nehru Yuvak Kenda to organise Essay Writing and Elocution competitions in all the schools and to enlist the winners by 24th January 2011.

(Action: Dist.Educational Officer and Dist.Coordinator, Nehru Yuvak Kendra, Anantapur)

Reviewed the status of convergence issues of last meeting, redressal status of Prajavani issues and the references addressed by District Collector to various departments and instructed the related District Officers to address the issues immediately and update online status. (Action : Related District Officers)

Inter departmental convergence issues raised during the meeting:

1. PD, DWMA requested SE, RWS to handover unused borewell in Shaiksanipalli village for taking up dry land horticulture. (Action: SE, RWS)
2. RDO, Anantapur requested the Registrar, Assurances and Lead Dist.Manager to send all the necessary documents duly signed to speed up alienation of land for construction of buildings. (Action: Registrar, Assurances and Lead Dist.Manager, Syndicate Bank, Anantapur)
3. District Forest Officer requested Joint Collector, Anantapur to direct the MRO, Talupula to hand over the land allotted.(Action: RDO, Penukonda and MRO, Talupula)
4. Joint Collector, Anantapur requested the DEO, Anantapur to ascertain the status of sanctioned model schools from the Director, School Education.(Action: DEO, Anantapur)
5. EE, Social Welfare requested the Joint Collector to direct the SE, RWS for restoration of SS water connections provided in Residential School in B.Pappur (V) of Narpala mandal (Action: SE, RWS)
6. The District Revenue Officer, Anantapur requested the Chief Planning Officer, Anantapur to provide copies of reports relating to Flagship Programme and 10 major issues pending at Government level recently submitted to Hon'ble CM's office. (Action: Chief Planning Officer, Anantapur.)
7. The District Revenue Officer, Anantapur requested all the District Officers to furnish RTI progress reports to the Collectorate and also to update the status in WEBSITE. Requested to cover the subordinate offices in their jurisdiction in the RTI quarterly and annual reports. It is also requested to furnish the progress reports on Adhikara Bhasha in the format. (Action: All District Officers).
8. Special Officer, Tadipatri requested the Project Director, DWMA to fill up Computer Operator post in Tadipatri (Action: PD, DWMA).
9. Project Director, DWMA, Anantapur informed that the Government have enhanced the ceiling from 100 days to 125 days wage employment per family minimum wage rate from Rs.100/- to Rs. 125/- per day and requested all the District Officers to propagate the same during Rachabanda programme. (Action : All Special Officers)

The Joint Collector, Anantapur requested the Project Director, Housing, Anantapur to discuss with Managing Director, Housing Corporation with regard to pending sanctions immediately to avoid problems in the ensuing Rachabanda Programme and concluded the meeting.(Action: P. D., Housing Corporation, Anantapur)
