

Minutes of the Convergence Meeting held on 16-01-2012 at DWMA hall, Anantapur

The District Collector initiated the meeting and reviewed the electrocution deaths in the district due to handling of electrical lines by farmers on their own without intimating the TRANSCO officials. In this regard, the District Collector instructed for wide publicity through slides in cinema halls / cable network to sensitize the farmers to avoid deaths. The Special Officers to review this in mandal level convergence meetings.

**( Action: SE, TRANSCO / Special Officers )**

The District Informatics Officer, NIC, Anantapur is instructed to prepare report on Grievance Mechanism in the district for submitting the same to the Chief Secretary, Government of AP, Hyderabad with an emphasis on technical aspects.

The District Collector reviewed the redressal position of Grievance Petitions and instructed all the officers to update the online status before attending Convergence Meeting.

**(Action: All District Officers)**

The District Collector specifically instructed the Municipal Commissioner, Anantapur Municipal Corporation, Anantapur to immediately attend to closing the pot holes and road gaps within a week's time.

**(Action: Municipal Commissioner, Anantapur Mpl.Corporation)**

The District BC Welfare Officer is directed to report on the status of incomplete hostel buildings with reasons immediately

**(Action: Dist.BC Welfare Officer, Anantapur)**

The District Collector instructed all the District officers to attend Grievance meeting one hour before commencement so as to review the redressal of grievances.

**(Action: All District Officers)**

The Special Officers shall ensure conduct meeting on SC/ST atrocities on last Friday of every month.

**(Action: Special Officers)**

The District Collector instructed the Revenue Divisional Officers to inspect cinema halls and check the sanitary aspects, fire equipments in case of emergencies, and display of slides on closing of failed borewells to awareness among farmers. The Village Revenue Officers to sensitize the villagers in closing the failed borewells.

**(Action: Revenue Divisional Officers)**

The Chief Executive Officer, Zilla Parishad, District Panchayat Officer and Supdt.Engineer, RWS shall coordinate and closely monitor the drinking water position in problematic villagers.

**(Action: SE,RWS, CEO, ZP and DPO)**

The Chief Exe.Officer, Zilla Parishad is instructed to see that all dilapidated school are locked up immediately.

**(Action: Chief Exe.Officer,Zilla Parishad)**

The District Revenue Officer requested all the District Officers for successful conduct of Revenue Sadassulu commencing from January 18<sup>th</sup> to March 17<sup>th</sup> 2012 in the district.

The District Collector released the Posters / Pamphlets on Revenue Sadassulu and concluded the meeting.
