

Minutes of Convergence meeting held on 18.7.2011

At the outset, Additional Joint Collector congratulated all the officers for successful conduct of ID cards to the Licensed Farmers distribution programme and reviewed the action taken reports on the previous meeting issues.

PD DRDA requested all the officers from whom payments are pending to Prasanthi ZS to clear off immediately keeping in view of the seriousness of the issue.

PD DWMA informed that Dry land Horticulture, MG Vana Nurseries and fodder development are the three programmes which facilitate poor cultivators of the district and hence requested all the Special Officers to popularize the programmes.

Instructions issued

- DEO / PO RVM to furnish text books disbursement updated school wise lists to the Dist. Collector.
- MEOs to cross check the mid day meals accounts with the attendance and give the requirement to the Tahsildars every month and any variation in attendance and midday meals will be viewed seriously and actions will be initiated on the defaulters.
- All committees formed previously to improve the education standards in the district to continued to function during this year also.
- Special Officers to inspect schools, hostels, KGVBs while visits to villages and see that village level functionaries of all departments to participate in their visits.
- The DM & HO to concentrate on Family Planning targets/achievement in the backlog areas particularly in urban areas. For this the PD MEPMA , Women & Child welfare to motivate the village level functionaries to complete the targets.

During the meeting issues relating to Housing, Horticulture targets, Demolition of dry toilets and providing of alternative arrangements , Education, Distribution of Artisan Credit Cards' distribution, Women welfare department interviews for AW workers, providing Eggs to children, Extending Insurance by Labour Department to the NREGS wage seekers, Updating of online RTI Progress reports are discussed.

Special Officer Putlur / DTWO informed that in Balampalli (V) of Putlur mandal Mandal Parishad Elementary School building is in dilapidated condition and requested to take up repair works immediately.
