

Minutes of Convergence meeting held on 23.5.2011

Brief Review on Agriculture department's Seed Distribution programme for Kharif 2011-12 was taken up and the District Collector instructed

- To commence distribution on 25th onwards, and see that more number of counters are organized on 30th and 31st of this month.
- To ensure on par with Groundnut, Red gram seed and other seeds and seed treatment chemicals also available in all distribution outlets.
- To see that no negative sign to reach public on any of the distribution procedures.
- To take all precautionary measures on purchased seed not to cross the state borders.
- To utilize the services of any state government employees for the distribution programme based on the local needs.

Drinking water position was reviewed in the meeting and the

- SE RWS is instructed to monitor the situation very closely and see that there is no scarcity for drinking water.
- CPO to review the CDP drinking water works grounding situation each executive agency wise during every Monday meeting.
- DPO to give the latest list of villages where drinking water supply is being hindered for the cause of motor burn cases.

Detailed Review on the issues relating to **Beedi Workers** in the district was taken up with the Dy. commissioner of Labour and instructed

1. To provide all amenities those are entitled to the workers to be done at district level immediately.
2. To see that all housing representations of the workers to be clear off in the Indiramma programme or any scheme as the case may be
3. To protect the welfare of the workers as much as possible

The District Collector reviewed the implementation of 212 G.O in animal Husbandry department and instructed not to do any mistakes which will cause unnecessary complications.

Review on **SSC results** in the district was taken up and instructed to organize one felicitation to the toppers (50 members) on 26.5.11. for this

- The DD SW, DBCWO, DTWO to call the HWOs achieved 100 % pass in 10th class and students got more than 520 marks and top students in all hostels.. And also to display the names of the toppers on hostels notice boards.
- The DEO to invite 100 % achieved ZPHS Head masters and top ranked students (got more than 550 / 570) got to an extent of 50 members to the function.
- To prepare top 20 schools and last 20 schools list to have a separate meeting to improve the performance of the SSC results.

Other instructions issued during meeting:

- A. The RIO and ATP Mpl. Commissioner to conduct joint inspections on the permissions issued to run private educational institutions in the commercial complexes local in busy centers of the corporation.
- B. The A D Horticulture issue details of Horticulture relief payments made to the farmers
- C. The SE PR to complete Kamarupalli (V) of Anantapur ® mandal Sanctioned road work in housing colony with NREGS tie up immediately. Action :: SE PR

- D. The AD Fisheries and the ATP municipal commissioner both together to inspect the site allotted to fisheries department to handover and to meet the D.C. Action:: AD Fisheries & ATP Mpl. Commr.
- E. To see that the NREGS wage seekers to be covered in Labour departments insurance scheme at the earliest. Action :: Dy.Commr. of Labour & PD DWMA
- F. To finalise the rationalization of teachers at the earliest. Action ::DEO
- G. To disburse the salaries to the 104 service employees by tomorrow 11.00 PM.

Action :: DM & HO / Supdt. GGH

The District collector reviewed the issues raised during the last week.

Other issues Discussed in the meeting::

- The Regl. Intermediate Officer informed that the advanced supplementary examinations are scheduled from 27th in 67 centers, and requested all the line departments (Police, Revenue, Postal, Dy. commr of Labour, DM& HO RTC, etc.,) to cooperate on the similar lines as was done in the past.
- The E.D S.C Corporation requested the IDC department to give progress under S.C P of their department. Action :: EE IDC
- The District Revenue Officer, informed that DIET CET examination is scheduled on 29.5.11. As more number of centers are being organized all District Officers and A.D level officers also drafted for organizing the examinations. Hence requested to oblige the orders of the District administration being served by the DEO. Action:: All Officers.
- The Chief Planning Officer explained the latest position of installation of Automatic Weather stations in the district. In this regard the Dist Collector instructed the CPO to ask the concerned agencies to participate in the next convergence meeting. Action :: CPO
- The P.D Housing requested for early furnishing of estimates for the housing colonies layouts electrification work . Action :: SE TRANSCO
- The P.D. Housing informed that during Rachabanda 74638 representations relating to housing department were received and the entire list after processing to be submit to the state level by 13th of June. In this regard it is pointed out in Dharmavarm Municipality 900 applications which were not accounted for to be settled. In this connection the district Collector instructed the CPO and PD Housing to jointly visit the Dharmavaram municipality and check the counterfoils availability status to settle the discrepancy
Action:: CPO & PD Housing.
- The Superintendent Govt General Hospital raised an issue that in front of the compound wall of General Hospital mobile vendors are placing shops on the foot path causing a lot of inconvenience to patients and storing garbage, hence requested to evicting them at the earliest. Action :: ATP MPL Commissioner
- The District Revenue Officer informed that one "B" type quarter which is at present under the occupation of ACB office is vacant to be let out to the occupation of any officer not below the cadre of Superintendent.
- The PD housing requested all Special Officers (except, Gandlapenta & Tadimarri) to see that all Housing representations of Rachabanda programme to be processed by the end of this month.
