

Minutes of Convergence meeting held on 27.6.2011

At the outset the District Collector asked all Officers to introduce themselves and informed to feel free and friendly in the administration to improve the image of the District. Further he advised all the officers

- To make the platform of convergence meetings much more meaningful by concentrating on the areas discussed / focused in the meeting.
- To pay more serious concern on the issues of farmers / weavers as the situation is alarming in the district.
- To include the works in civil nature also in the mandal level convergence meetings.

Other instructions issued in the meeting :

1. **All District Officers** to personally attend for the Grievance cell on every Monday . Prior permission of the District Collector to send deputies is compulsory on genuine reason. All A category petitions to be solved immediately .
2. **The SE RWS** to gear up the departments mechanism to raise up to the situation and see that there is no drinking water scarcity in the district. Providing safe water and clean environment are the two important areas to be concentrated.
3. **The SE TRANSCO** to be alert and ensure that there are no abrupt power failures and all rural areas are connected with power. And also to ensure that all contact Numbers of the concerned TRASCO and RWS personnel to be displayed in the notice boards of Panchayat offices through the panchayat Secretaries.
4. **The Anantapur Municipal Commissioner** to personally take interest in rectifying the minute mismanagements in urban water supply .
5. **The PD Housing** and the Joint Collector to meet separately to analyse the critical issues of Housing and report compliance. P D to take steps to see that all about to complete houses construction work should not to be stopped without fail.
6. **The PD IKP (R)** to see that SHGs to be utilized for other social development works also.
7. **The DM & HO** to see that sufficient stocks of medicines be available in all PHCs for all diseases particularly dog & snake bites. Further DM & HO to see that the Medical Officers and medical persons are totally involved entire day for work to reach the service to the door step of the public.
8. **The Chief Planning Officer** to consolidate the minutes of the mandal level convergence meetings conducted on Fridays.

The District Collector informed that the District Administration decided to organize Sri Krishnadevaraya Pancha Satabdhi Utsavaalu this year also on 6th, 7th and 8th of August on the similar lines of last year and instructed to have a separate meeting with the line departments and concerned organizations to chalk out the plan to celebrate in a grand festive atmosphere.

Review on the issues discussed during the previous meeting was taken up and instructed

- All Officers to be specific and sufficient in furnishing information / reports.
- Reviews to be pinpointed and meaningful at any level.
- Action on the issues discussed to be invariably taken.
- All officers who ever deducted EPF amounts for the outsourcing employees to remit immediately to the Prasanthi Zilla Samakhya.
- EE Social welfare to give estimate to construct toilet block in Dharmavaram Children Home immediately.
- To have separate discussion on the meeting expenditure of organizing national festivals.

The District Collector reviewed the Text books distribution status and Housing department Rachabanda petitions clearing status during the meeting.

Other issues Discussed in the meeting ::

➤ The P.D Women & Child welfare requested to fix schedule for conduct of interviews to fillup the vacancies of AW workers and Helpers . The District Collector instructed to meet the Addl Joint Collector along with file . Action :: PD W & C. welfare & AJC

➤ The EE Social Welfare raised an issue of getting permission to hand over advance position of land to construct Model school buildings in this academic year. The Dist. Collector instructed to circulate the file to the Collector for getting permission of the CCLA.

Action :: EE SW

➤ The EE Social Welfare requested to give power supply to the bore well drilled for Drinking water purpose in Social Welfare hostel of Thimmapuram of Kambadur Mandal.

Action :: SE TRASNCO

➤ The RDO Dharmavaram raised an issue of low voltage problem in Kalyanadurg and Ramagiri mandals and requested for rectification. Action :: SE TRASNCO

➤ The RDO Dharmavaram requested to drill bore wells in Housing colonies for drinking water purpose in Nagireddy palli, Avuladatla and Mallapuram villages of Rayadurg mandal. The Dist Collector instructed to complete all possible works and to take immediate necessary action to complete all drinking water works in the District by giving more priority to Housing works.

Action :: PD Housing , SE RWS.

➤ The DD SW / Special Officer, Tanakallu requested for drilling of separate bore well to integrated hostel building as the present single combined bore well to villagers and borders is unable to cater the needs. The District Collector instructed to write letters to the concerned officers. He advised that any issue in the nature of capital expenditure to be in writing only. Action :: DD SW SE RWS and DD GWD

➤ The P.D DWMA informed that for augmentation of drinking water source where ever feasible, percolation tanks to be proposed under NREGS. Action :: SE RWS

➤ The RDO, Dharmavaram informed that the public are complaining against the ADCC bank recovering loans forcibly and speedily in Dharmavaram. The District Collector asked the D.M . ADCCB to meet the District Collector .

➤ The RDO, Dharmavaram informed that all banks in Kambadur mandal are insisting for Adangal extracts for issuing crop loans as against the decision of the District Administration.

Action :: LDM

➤ The Joint Collector raised an issue of Ration card applications received in Rachanabnda seeming to be crossed the population. Hence instructed to be careful enough while conducting enquiries. Further the ration card applications enquiry also to be completed in Anantapur at the earliest. Action :: RDO ATP

The District Collector requested to all officers to give top priority to CM assurances and also to sort out the Rahabanda issues at the earliest with special focus on Garladinne programme for which the H'ble Chief Minister attended. The Chief Planning Officer is instructed to compile all issue with current status and to be ready with reasons for any incomplete works.
