

**Minutes of the Coverage Meeting held by District Collector, Anantapur on 7-12-2009
at DWMA Conference Hall, Anantapur**

The District Collector, Anantapur at the outset reviewed the redressal status of Prajavaani Petitions and instructed to give priority in solving the maximum number of A Category petitions.

It has been instructed to put efforts to extend insurance coverage to all sections of the workers including excise and construction labourers.

Next the status of convergence issues sorted out, Pending and under process since beginning of conducting meetings has been reviewed by the District Collector.

Out of 145 issues 105 issues were sorted out and 20 are under process and remaining 20 pending. In this regard the District Collector instructed the concerned Officers to solve the issues at the earliest.

The issues yet to be sorted out are annexed, along with the instructions of the District Collector to take necessary action.

After that this meeting issues were taken up in the meeting.

- The D.F.O Social forestry informed that more than 10.00 lakh seedlings are available with the Dept and requested to make use of them .

Action :: All Special Officer, DEO, DM & HO.

- The Project Director, DWMA informed that 80000 special variety seedlings of Tamarind available to be supplied free of cost if 100% survival assurance.

Action :: All Special Officer, DEO, DM & HO.

- The District Revenue Officer raised an issue that in Kothacheruvu Mandal Mallempalli H/o Pothulanagepalli (v) the canal from Locherla tank is being dug with variation to already plan causing trouble to village. Hence requested to pursue the issue.

Action :: SE MI

- The Revenue Divisional Officer, Dharmavaram requested to settle the payments for the completed repair works done to Ramagir (m) Perur tanks and Brahmasamudrm tank.

Action :: SE MI

- The Joint Director, Agrl. Requested the Pranganam Officer to provide Mahila Pranganam to take up training to Mahila Adarsha rythus for five days.

Action :: P.O Mahila Pranganam

- The Pranganam Officer, Mahila Pranganam raised an issue that there is drinking water problem in their institution like minor repairs to bore and motor and requested to sort immediately as many training programmes are being organized there.

Action :: SE RWS.

- The S.E M I requested to take up land acquisition in Mudigubba Mandal under Jilledukunta tank at Gunjepalli Village, for which plans were already submitted and due from 2008.

Action :: DRO / RDO

- The PD DWMA informed that RLDP fodder development programme can be tied up with NREGS in Nallacheruvu and Gandlapenta mandals.

Action :: JD AH

- The DD Adult Education, Special Officer, Atmakaur, raised an issue that there is dispute in Atmakur village regarding village site previously occupied for community toilets now demolished. The District collector instructed that the Gram Panchayat to make resolution regarding the issue. **ACTION :: DPO**

- The Joint Collector requested all the Special Officers to visit Kasthuribaa Schools during their visits to mandals to observe the maintenance of the schools is in proper way. **Action :: Special Officers.**

- The SE TRANSCO requested to provide sites for the sanctioned Section Offices of Trasco to take up construction at Rappthadu, Brhmsamudram and near Police Training College, Anantapur. **Action :: JC / DRO**

- The District collector instructed the DRO to give detailed instructions on maintenance of Village Information System and the Departments to give information from inception of their schemes and the cost of publishing of registers to be shared by certain departments. **Action :: DRO, PD DRDA, DWMA, APMIP,SSA, Horticulture.**

Finally the District Collector in the concluding remarks requested all the Special Officers to see that more number of wage seekers to be provided work under NREGS from December onwards, to improve the recovery position in IKPs and the JMLBC meeting to be completed at the earliest.
