

Minutes of the Convergence Meeting held by District Collector, Anantapur on 15.3.2010 at
DWMA Conference Hall, Anantapur

At the outset, the District Collector held a brief review on the progress of departments under 20 point programme for the month ending February 2010 and instructed all the departments to achieve 100% target fixed for the financial year 2009-10. It is also instructed to all the Departments (particularly, the PD Housing and Mpl. Commissioner Hindupur municipalities) to revise the progress report of Feb 2010, as the report submitted is not reflecting the original performance of the Department.

The District Collector reviewed the action taken on the previous convergence meetings issues and instructed as follows:

1. To give daily SMS on the progress achieved under Family planning with special reference to Anantapur Urban. Action :: DM & HO, PD IKP (U) & (R).,
2. To update the information in Anantapur Official website.
Action :: All the Concerned Officers.
3. To invite the departments paying surcharge for non installation of capacitors to attend in the next Monday convergence meeting. Action :: SE TRANSCO
4. To submit feed back report on the organized special meetings at Mandal / Divl level to know the problems on Drinking water from the villagers. Action :: SE RWS
5. To organize a special meeting with the Rig Owners not to drill Agrl Bore wells in the farmers fields with out the authorized feasibility certificate. Action :: DD GWD
6. To campaign again on **NO MORE BORE**. Action :: DD GWD

It is also instructed by the District Collector to prepare one page note by various departments, with value addition points (to place in the Anantapur website) as follows :

- o AD Horticulture prepare notes on the Horticulture related items with special reference to the District condition.
- o J.D Animal Husbandry on par with general information, the number of cross breed milch cattle population in the district, need to improve the number and milk production and also need to develop the managerial skills.
- o J.D Agriculture on salient features of the district, total production and its value, Mitigation of Drought situation, low production of G. nut reflecting in the economy of the state etc.,
- o PD Housing also to prepare one page note consisting of salient features, progress and critical gaps, and also with special highlight to reforms adopted in the district in reaching the service to public.
- o SE MI, AD Handlooms & Textiles, ED S C Corn., D.M NEDCAP also to prepare note on similar grounds.

AFTER WHICH OTHER CONVERGENCE ISSUES WERE DISCUSSED IN THE MEETING

- ❖ The District Collector informed that as per the latest Supreme Court Judgment all the Sarpanches, Village Revenue Officers, Tahasildars and Rev. Divl Officers are responsible for any child deaths in the open dried-up /failed bore wells. Hence instructed all officers to see that no such bore wells are there in villages and also instructed to issue instructions to that effect. The Special Officers to invariably take this issue to village level and make aware of the severity of the problem. **Action :: Special Officers. DRO. & RDOs.**
- ❖ The District Collector instructed all bank linked beneficiary oriented targets of 2009-10 to be sanctioned by this month ending.
Action :: LDM & All Concerned Officers.
- ❖ The Joint Collector informed that to update mutations in revenue records a special programme " MEE BHOOMI _ MEE PERU " is being organized in the District and requested all Special Officers to monitor the progress under this programme during the visits to villages. **Action :: All Special Officers.**
- ❖ The Joint Collector informed that in finalizing the Integrated Survey on ration cards, pensions and Housing the District is lagging behind , due to many problems. The Housing list finalization also needs to be expedited Hence requested to complete at the earliest. **Action :: RDOs. PD DRDA, and PD Housing.**
- ❖ The Dist. Collector instructed to inform to all the related officers, whenever MPDOs meetings were organized at Dist. or Division level, to take part and to save time. **Action :: CEO ZP.**
- ❖ The Dist. Collector instructed all the Special Officers to stay at allotted mandals to achieve 100% family planning with co-ordination of DM & HO. In Anantapur Urban special motivation camps to be organized by the Women Officers, to the parents waiting for Male baby explaining them the harms of gender disparity. As this is fag end of the year all officers to spare 25 days to Family Planning motivation to get 100% achievement. **Action :: All Special Officers**
- ❖ The Dist. Collector quoting the case of Chilamathur Madal. Settipalli Village Bi - nami NREGS payment case, representation received in Prajaavanni requested all the officers to see that no such payments were made. It is also requested to see that all BPL members and the NREGS wage earners to cover under insurance scheme by paying Rs 15/- per annum to an assured sum of Rs 1.00 lakh. **Action :: All Special Officers.**
- ❖ The Dist. Collector instructed all Special Officers to concentrate on construction of Model toilets in villages. This years target is to construct 1000 toilets and brought to use with local publicity. Next all Housing colonies and all houses to facilitate with bath cum toilet facility and see that no house is without toilet in all villages by awaking the public on this sanitation concept.
Action :: PD Housing & All Special Officers

- ❖ The Dist. Collector, informed all the officers, that the newly introduced Village Information System in the District is going to attract the attention of the entire country and there is possibility that it may become a National Programme, hence instructed all officers to see that this system is improved qualitatively. The Dist. Revenue Officer to co-ordinate the VIS and also to monitor the publication of required register with all departments co-ordination. **Action :: D.R. O and All Dist. Officers.**
- ❖ The Dist. Collector instructed the DRO to see that all Agriculture Bore Well registers recorded in 2004 to be updated recently. The SE TRANSCO to prepare the village wise - farmer wise, unauthorized power tapping to irrigate the Agrl. fields. Lists to be furnished to the concerned Tahasildars and DD GWD to take necessary action. **Action :: SE TRANSCO, DDGWD, & Tahasildars.**
- ❖ The Tahasildar Anantapur informed that an amount of Rs. 48,000/- is due from the DD Social Welfare being the expenditure incurred during the H'ble Chief Ministers visit to District. **Action :: DD Social Welfare**
- ❖ The District Revenue Officer informed that amounts are due from the SE HNSS and SE RWS for the H'ble Chief Ministers visit to District during the year 2008 **Action :: SE HNSS & SE RWS**
- ❖ The Dist. Collector instructed the EE Public Health that a day wise progress to be sent to the Dist. Collector on the arrangements to release the drinking water from CBR balancing Reservoir. PD APMIP, AD GWD, ADA of Kadiri were assigned with special duty of monitoring the situation, and hence instructed the EE PH to co-ordinate between the AEs / DEEs of Public Health and the three special officers assigned with this work. **Action :: EE PH**
- ❖ The Municipal Commissioner, Anantapur informed that there is a need to shifting of electric Poles is needed where Roads were widened. **Action :: SE TRANSCO**
- ❖ The Special Officer, Kadiri informed that in Kalasamudram village to take up NREGS works, the Forest Department permission is needed. **Action :: DFO (T)**
- ❖ The Dist. Collector instructed the PD DWMA to issue circular to delete the names of the registered wage seekers who are absent for work for a long time. The circular also to be placed in the Anantapur web site. Any real wage seeker can be issued a new job card at time of need. **Action :: PD DWMA.**
- ❖ The Dist. Collector instructed to reiterate the need of verifying the musters by the muster verification Officers invariably. Defaulting Officers in this context to be charged. In this regard all PS / VRO's who ever may be the Muster Verification Officers to be instructed to follow the instructions scrupulously. It is also informed that all the Special Officers are also responsible for any sort of irregularity in NREGS as per the latest G.O of Govt of A.P. **Action :: RDOS and CEO ZP.**

- ❖ The P.D DWMA informed to all the Special Officers that the new guidelines were issued in changing the members of Purchasing committees and are under circulation. As per the new guidelines the members are MPDO, APD, DWMA, APO NREGS , who are competent to purchase any sort of small items at work sites like Shades, Medical Kits, etc.,. It is also requested to send the weekly inspection reports invariably even NIL reports. As the Social audits are yielding good results in improving the system, it has to be ensured that in all noted 5 (Sarpanch, VRO, PS, ZPTC and V.O) places the lists of beneficiaries / payment received to be made available. **Action :: All Special Officers.**
- ❖ The E D., S.C Corn. informed that 145 cases power supply connections pending with SE, TRANSCO for which already paid the deposit amount of Rs 6000/- . For this the Dist. Collector instructed the SE TRANSCO to complete this works before 25th to include this years progress. **Action :: SE TRANSCO**
- ❖ The P.O Rajiv Vidya Mission requested all the Special Officers to monitor the functioning of School Monitoring Committee at villages.

Action :: Special Officers

Before closing the meeting the Dist. Collector informed to the Revenue Divisional Officers, that in addition to regular revenue work, Construction of toilets, 100% achievement in Family planning operations and Institutionalization of Deliveries are the social works attached to them. It is also instructed the SE MI to bring the list of tanks filled with water for the next meeting. To have a special meeting of SE RWS with the CEO ZP, and SE TRANSCO to discuss on 360 critical gap works to be completed immediately. The PO RVM to look into the rationalize the teaching staff in interior areas schools, and also to take up serious inspection on all the RBC schools managed other than by RDT in the District.

Finally the District Collector concluded the meeting greeting all the Officers happy telugu new year " UGADI" .
