

## **MINUTES OF THE MEETING WITH THE POSTAL OFFICIALS ON 08.04.2010 IN DWMA MEETING HALL, ANANTAPUR.**

The District Collector has welcomed Postal Officials to the monthly meeting.

1. While reviewing them, the District Collector, found that out of 19032 suspense accounts 4795 accounts only were opened to the wage seekers. The District Collector directed the postal authorities to ensure opening of accounts whenever wage seekers approached.
2. It was agreed to sort out the issues in convergence meeting held every Friday at each Mandal level.
3. The District Collector has reviewed the Mandal wise enquiry status in respect of social audit and observed that the allegation leveled are on 482 BPMs, out of them enquiry has been completed on 137 BPMS only; out of 137 enquired the allegations were proved on 3 BPMs only.
4. The Postal Superintendents agreed to fix up monthly target to conduct enquiry on the BPMs and requested to speed up the enquiry process.
5. Further the District Collector advised them to conduct surprise visit on BPMs wherever the wages distribution is going on; and requested them to take statements of the wage seekers if any discrepancy in distribution of wages is noticed and opined unless they undertake these measures things may go out of control.

6. The District Collector requested the Postal officials to display the phone numbers and other details of the officers to whom the wage seekers have to give complaint on BPMs and also requested them to put Primary information board at BPM offices as per RTI Act.
7. The inspector of posts Anantapur (east sub division) told that the MPDO Yellanur did not provide vehicle to get huge amount of wages from Bank to BPM office. The District Collector requested the special officers and Assistant Project Directors to discuss such issues in Friday Convergence meeting at Mandal level.
8. The inspector of posts Penukonda complained that the Field Assistants in Somandepalli are issuing pay slips to wage seekers earlier than issue of Pay orders to BPM. The District Collector opined that it is not correct and the pay order should be given first to the BPM.

Finally the District Collector requested the postal authorities to develop internal monitoring and checking machinery to contain misappropriation in implementation of NREGA.
