

**Minutes of the Convergence meeting held by the District Collector on 2.11.2009 at DWMA  
Conference hall, Anantapur**

---

In the inaugural address the District Collector congratulated all the Officers for the successful conduct of Kalyanamasthu Programme in the District. Next all the Officers have been instructed present invariably for the Convergence meeting, and the attendance of the Officers will also be reviewed from now onwards.

After that it has been instructed by the District Collector as follows:

1. To review the progress under Joint Identification of beneficiaries and processing of application so far received, PD DRDA and JD Animal Husbandry to participate in the MPDOs meeting scheduled to be held on 3.11.09. **Action :: PD DRDA and JD AH**
2. To complete all desilting works by the end of 10.11.09 at Maddileru, Yogivemana, BTP and Pedaballi Reservoirs and Dharmavaram Tank work with the Departmental funds available with Minor Irrigation or under NREGS. **Action :: SE MI & PD DWMA**
3. To complete all Drinking water supply works in full shape immediately at Gooty, Hindupur and Yellanur. **Action :: S.E RWS, S.E TRANSCO, S.E M.I**
4. To provide electricity immediately to the completed Housing Colonies.  
**Action :: S.E TRANSCO & P.O Housing**
5. To conduct enquiry cum orientation programme at village / mandal level on Abhaya Hastham beneficiaries identified in the District. Also special officers to inspect schools and Mid-day meals programme implementation during their visits to villages.  
**Action : All Special Officers.**
6. The DD Adult Education reported that in Thopudurthy village of Atmakur (M) no releases were made since last 9 months, as it is too difficult to provide food with out bill payment by the cooking agencies. To improve the monitoring tools and to take action on defaulting MEOs in discharging duties . To reiterate in writing to all MEOs to take the services of Vidya Volunteers where ever necessary. **Action :: DEO**
7. To publish article on plantation programme in Govt Building premises in the District news letter "ANANTHA PRAGATHI". **Action :: PD DRDA, & PD DWMA**
8. Stickers on the special Drive "MANAM VINDAAM" and "VINELAA CHEDDAM" to be stuck in all Class rooms in all schools. **Action :: PO RVM , PO Mahila Pranganam & DEO .**
9. All Statutory meeting of Departments should be conducted as per the Guidelines. Such Files should be circulated to the District Collector well in advance to avoid clash in dates.  
**Action : All Concerned Departments**
10. All Officers to participate actively in the Army Recruitment rally scheduled to be held from 16<sup>th</sup> to 22<sup>nd</sup> of this month in the District. Though it is a difficult task, it has been decided to hold the rally in the district keeping in view of the unemployment situation. For this purpose work wise sub-committees headed by the District Officers has been chalked out and the same will be communicated to all for necessary action. At all Mandal headquarters a preliminary screening test to be conducted with the involvement of MPDO, Station House Officer, Tahasildar and PETs of Schools. For publicity of this recruitment rally, it has been instructed to advertise in all local TV Channels. All the Panchayat Secretaries and Village Revenue Officers to give publicity in villages on this rally. To hold a meeting with officers separately at District level.  
**Action :: District Sport Dev. Officers,  
JC, RDOs and All the Officers.**

Next the present meeting issues of convergence taken up

- SE TRANSCO requested to submit the Electricity accidental death cases along with the Postmortem report, FIR and Legal heir certificate for early settlement. There are 69 cases ( 22 animals ) pending since last 3 years. The list to be furnished to Revenue Divl. Officers for necessary. **Action :: ACTION :: SE TRANSCO, RDOs and Tahasildars.**
- PD DWMA requested for taking up of plantation programmes of Horticulture in any Govt buildings and institutions under NREGP with 100% subsidy, particularly in Schools, PHCs, premises where 5 to 8 Acres of land is available . **Action:: DM & HO, DEO & All Officers.**
- PD DWMA reminded all Special Officers on the work of visiting at least 1 work per week and to submit the inspection report in the format already communicated to all. Only reports from 10 or 12 officers are being received, so requested all the Officers to send reports. **Action :: ALL Special Officers.**
- The District Sports Development Officer requested to develop School play grounds under centrally sponsored Programme of Panchayat Youth Khel Kreedaa Abhyasan. All the AEEs DEEs of PR Department to take up these works before December ending as the Central programmes are to be completed as per guidelines. **Action : SE PR**
- Sub- Collector Penukonda requested all requisition officers to submit land alienation proposals only in the prescribed proforma to save delay in settling the issues. **Action :: JD (Agrl), PD DWMA & any other**
- The Joint Collector raised the previous issue of replacing sand filters in SSS summer storage tank in B.K.Samudram tank, as the work can not be taken up under NREGS, it is requested to consider under 12<sup>th</sup> finance. **Action :: CEO Z.P and SE Public Health.**
- The P D Housing requested all special officers to collect the village wise / beneficiary wise bank statements from all bank branches for the releases made by the Housing Department to take up audit by the Charter Accountants at Divl level. The LDM to write letters to all bank branches to provide lists to Special Officers . **Action :: LDM & Special officers**
- The District Collector opined that in Apatbandhu programme - the F.I.R.s are not being received in time to settle the cases. **Action :: ASP & RDOs.**
- PD DWMA requested the ASP, to instruct the SHO Vajrakarur to register the complaint petition filed on the Field Assistant in Vajrakar Village, as the SHO is refusing to take the complaint. **Action :: ASP**
- The CEO Zilla Parishad requested to omit the staff of Mandal parishad offices, where less staff is there for the integrated survey of Ration cards pensions, and housing. **Action J.C , PD DWMA & CEO ZP**
- The Joint Director Agrl. & Special Officer, Singanamala raised an issue of construction of speed breakers/ sign boards at Maruvakomma turn at Singanamala Cross (which is a vulnerable turning and frequent accident prone zone) as 12 persons died in a recent accident. **Action :: SE R&B, Commr.Transport, R.D.O and Police Department**

- P D DWMA, was asked to provide list of lands where nurseries are grown for alienation to revenue authorities. Similarly SE TRANSCO sought land alienation for sub-stations.

Action :: DWMA, RDOs / Sub-Collector

Finally it has been concluded by the District Collector instructing all the concerned officers to make arrangements for Army recruitment Rally.
